First-time Law Student Users:

1. Go to CALI (www2.cali.org) or from Drexel Law Library website (www.drexel.edu/law/library/).
2. Under Resources, go to *Electronic Databases* link, then locate CALI, *Center for Computer-Assisted Legal Instruction* on the list and click the link.
3. At the "MY CALI" logon, click "Not a registered user yet?"
4. Follow the instructions at "CALI registration." Fill out the form. You will need your email address and you will be asked to create new username and password.
5. You will be asked to enter Drexel's CALI Authorization Code which can be obtained at the Law Library Circulation Desk.

Returning users:

1. Once you have registered, you will only need your email address and CALI password to login.
2. Select the particular CALI lesson by selecting Lessons under in the top toolbar.

Electronic Resources

CALI Lessons provides law students with learning tools and study aids. They cover standard law school courses, for the first, second and third year of law school. This collection has over 600 interactive, computer-based lessons covering 32 legal education subject areas.



CALI lessons help students gain familiarity with a topic prior to class, review a topic or supplement notes after class, and review for exams. The descriptions contained in the online catalog provide information about the specific legal issues presented in each exercise and offer suggestions for effective use.

CALI lessons are written by law faculty and librarians and are regularly reviewed and revised. The format of the individual lessons varies according to the educational objectives of the author.

Lessons by Casebook

The lessons tailored to work with over 50 casebooks that include: Civil Procedure, Contracts, Criminal Law, Evidence, and Torts.

Lessons by Course Outlines

Lessons are also organized by course outline. The outlines include: Business Associations, Contracts, Copyright, Criminal Law, Family Law, Legal Research and Writing, Property Law, Remedies, Tax Law, Torts, and Trademark.
