Dear Classmates:

Hi, and thank you for your interest in our Public Interest Experience (PIE) Grants program. We're excited to let you know that there will definitely be funding available for 2014 summer employment. The amount of available funding depends largely on what we, the students, can do in the coming weeks as we prepare for the PIE Auction being held on Thursday, February 27, 2014 from 6:00pm – 9:00pm at The FieldHouse. In this letter we'd like to tell you about the PIE Grants Board, the application process, and our current priorities.

THE PIE BOARD

The PIE Board is a committee of students working *primarily to raise funds* for students' Public Interest Experience summer grants. The current Board membership is listed at the end of this letter. It consists of individuals who were involved in the PIE Program and received grants last year, as well as students who anticipate applying for future PIE Grants.

THE GRANTS COMMITTEE & SELECTION PROCESS

The Grants Committee is a subset of the PIE Board which has drafted this application and will oversee the application process. The application process has been approved by the administration and is described for you on the following pages. Please note that all students seeking public interest employment are encouraged to apply, including those who received PIE grants last year.

The application is due Wednesday, March 26, 2014 by 12:00pm. The Selection Committee will hold an interview with each applicant. After interviewing all applicants, the Selection Committee will determine the 2014 grantees. Grant Recipients will be announced by Friday, April 18, 2014. Those students selected for PIE Grants will be named Drexel Law Public Interest Summer Fellows. Students who are applying for grants, themselves, are barred from serving on the Selection Committee.

PRIORITIES

The PIE Board has identified two major priorities in selecting grantees. One is to further prepare students pursuing a career in public interest law to be experienced candidates for highly selective public interest jobs after graduation. The other major priority is encouraging students' enthusiastic involvement in the public interest sector, which can become a financial impossibility when public interest internships do not provide compensation. We value the full spectrum of public interest work, including direct client services and systemic advocacy.

To those students seeking funding for judicial internships: PIE Grants will not be awarded to students seeking judicial internships. The PIE Board has discussed this issue at length, and has come to the conclusion that there may be instances when a student's internship wholly aligns itself with the priorities described above.

Currently, however, we recognize that most law school students throughout the country who work as judicial interns do so on a volunteer basis. Judicial internships mainly assist the efficiency of an individual judge, not

the underrepresented parties who otherwise remain in need. In short, rare is the case when a judicial internship will receive funding that is earmarked for PIE Grants.

Our goal is to fund as many students as possible. Ideally, the PIE Board would love to fund every student who applies. However, funding opportunities depend on - and are limited by - the amount of money we are able to raise between now and the close of the application process. Additionally, we fully intend for students to maximize the use of Work-Study funds.

You can help expand the pot of funds. Talk to your friends and family, and tell them about our Public Interest Auction occurring on Thursday, February 27, 2014 from 6:00pm – 9:00pm at The FieldHouse. Get them to donate items for the auction; ask them to join us for the evening of food, entertainment, and bidding; tell your professors that you want them to be there. The more people involved the more money we make, the more students will receive grants for summer employment. In order to qualify for a grant, volunteering is mandatory. Lastly, we hope you'll recognize that this effort has been manned by your fellow students. We are working very hard to ensure that money will be available to students this year so we all have the opportunity to access it. 

WHAT ARE PUBLIC INTEREST GRANTS?

Public Interest Employment Grants (PIE Grants) provide stipends to Drexel University School of Law students who are taking unpaid, summer public interest positions. These students are committed to the public interest and intend to pursue a public interest career after law school. The purpose of the grant is to offset the costs of living for students who incur significant financial burden by taking an unpaid position for the summer. The Public Interest Employment Grants Board (PIE Grants Board) hopes students will gain invaluable experience, skills, contacts, and insight to further enable them to find employment after law school in the competitive practice of public interest law.

How do I qualify for a grant?

- All students currently enrolled at Drexel University School of Law are eligible to apply for a summer grant regardless of academic year or GPA; however, priority will be given to 2L students, students who have shown a commitment to public interest law, and students who submit outstanding applications.
- The grantee must secure a position performing public interest legal work during the summer months of 2014. To qualify, the job placement must be both **nonprofit** and **nonpartisan**. Positions with the District Attorney or Public Defenders Association are also considered to be public interest. Students with unpaid judicial internships will **not** be considered for funding.
- In order to be eligible to receive a grant, students must volunteer to support the PIE Auction.

How much money can I expect to receive?

Funding will depend on the success of the PIE Auction and other student fundraising activities. Disbursements will be awarded considering, but not limited to, the following criteria:

- Full-time versus part-time work;
- Amount of financial assistance received through other sources, such as work-study (when available) or community grant;
- Specificity of the request; and
- The number of other students seeking grants.

General Allocation Criteria:

- Allocation criteria will be considered on a case-by-case basis, with appropriate consideration given for full-time employment. If your project or placement does not fit the traditional criteria, describe your circumstances on a separate piece of paper.

Instructions:

- All applications must be submitted by **Wednesday, March 26th, 2014 no later than noon (12:00 pm)**
- **Provide your resume** and certification page (included with packet).
- **Applications MUST be submitted in hard copy** and should be delivered to Karen Pearlman Raab, Director for Pro Bono and Public Interest Programs, in Suite 410 of the law school building, 3320 Market Street, Philadelphia, PA 19104.
- At the time of submission, applicants should sign up for an interview slot. The sign-up sheet will be available in Karen Pearlman Raab's office.
- Grant recipients will be announced by **Friday, April 18, 2014**. There will be a reception for grant recipients on Friday, April 24th.

What is required of a PIE Grantee?

- ✓ Upon completion of their summer positions, PIE Grantees may be required to provide a short essay describing their summer experience working in the public interest sector. This essay may be printed in the Drexel Docket.
- ✓ The 2014 PIE Grant Class will be required to participate in the following year's auction to raise funds for the 2015 PIE Grants.

What is the selection process?

The PIE Grants Board will assemble a Selection Committee of students, faculty, and members of the administration. This Selection Committee will select PIE Grant recipients and allocate funds. Only student members of the PIE Grants Board who are not applying for PIE Grants themselves will be permitted on the Selection Committee.

Each applicant will interview with a panel of students and faculty. The purpose of the interview is to get to know the applicant and clarify any questions which may arise from the application. All interviews are confidential and should last 15 - 20 minutes. Interviews must be completed prior to April 11th. Following the interview, the panel will discuss each application and make a recommendation to the larger Selection Committee.

The Selection Committee will then meet and make allocations of grants. Factors the Selection Committee will consider include:

- ✓ The certainty of the offer for a summer position;
- ✓ Whether the summer position fits the criteria for public interest as defined above;
- ✓ The applicant's commitment to public interest work, as displayed by past work or desire expressed in the personal statement and interview;
- ✓ The applicant's willingness to accept an unpaid position regardless of the guarantee of funding.
