What is Policy Surveillance?

Policy surveillance is the **ongoing systematic collection, analysis and dissemination** of information about public health laws and policies. Expanding upon this definition, the Urban Health Collaborative's policy surveillance project identifies best practices in select cities around the United States that are employing promising or effective policy, programmatic, and budgetary initiatives to promote health equity and improve health in cities. Researchers use policy surveillance to monitor policies at the **country, state, or local level** (Burris & Hitchcock, 2016).



Surveillance Methods

PHASE 1

We started this project with creating **three News Surveillance** Excel spreadsheets (one for each policy topic, e.g., Housing) to track the policy developments weekly/bi-monthly. Each spreadsheet had **four tabs** representing a city of interest: **Philadelphia, New York city, Washington DC, and Los Angeles**. We identified **five types of news sources**, and through an iterative process, the research team developed a customized list of the most relevant online news sources to monitor updates in each selected city on a bi-monthly basis.

This list will be updated as we discover new sources.

Our Sources

Twitter has become a popular platform for receiving instant news updates, which is why initially we included Twitter accounts of city legislators, school districts, and research institutes. We also believed that advocacy and research institution websites would be helpful to identify the most recent policy actions. However, as the project progressed we have noticed that these sources were not the most useful form of news medium. Legislator accounts focused on hearings and neighborhood events; advocacy websites were concerned with discussing a policy/project that has already been in place, encouraging policymakers to focus on a particular issue or advocating for state rather than city level policies. Research centers focused their postings on their own research projects and events - not on the local policies and programs, unless their research focused on the local topic.

City government websites, such as official websites of Environmental, Housing and Education Department, as well the City School District, became the main sources of information for this surveillance project with these four selected cities. However, other cities may have different structures of city websites, other research and advocacy organizations that are active in posting public health policy and program updates, and/or government officials who use Twitter to inform residents about city level plans. Thus, when expanding this work, it could be beneficial to initially explore the media action among all potential venues to determine the best places to monitor.

The number of news sources varied across cities, topics, and news types. Some cities had centralized websites (e.g.: DC Department of Energy & Environment (DOEE)) and most policies and programs on a particular topic could be accessed via this one source. Also certain news types were more useful than others for monitoring policies and programs (government websites vs. advocacy organizations).

Surveillance Methods

PHASE 2

To provide detailed information about the policies and projects identified in the *News Surveillance Spreadsheets*, we created **three Selected Regulations & Projects Surveillance** Excel spreadsheets (one for each policy topic – Education, Environmental, and Housing). Included in our surveillance are legislation, regulations, major programs, and budget plans at the city level. Once we identified a relevant policy or program, we added its title and a hyperlink to the spreadsheets. In order to be included these policy interventions had to have a proposed duration of 1+ year, and have been initiated after March 2017 (the start of the pilot) or been ongoing at that time). When we identified a policy or program development, we recorded its titles, description; timeframe; links to relevant documents (e.g. an executive order, bill description, plan summary); the original news source. To track the progress for a policy or program, our team goes back to the website where it was initially identified or a page with updates (e.g. Sustainability Plan quarterly updates) if available.

At the beginning of this project we actively referred to the news sources tables developed during Phase 1. As the project progressed, we have noticed a “snowball effect,” where when reading about one policy we would get a reference to another relevant policy or program. When that reference would lead to a




source that had an extensive amount of other policies mentioned, we would add it to the news table. If it was a stand along website, for example DC Vision Zero, we would do not add it to the list of news sources and only use it to monitor updates for that specific program.

As the project progressed, we identified new ways to categorize information. We have added the following columns to the Policy Surveillance Spreadsheets:

- Start Date – date the policy/program has started
- End Date – date the policy/program is expected to end
- Last Checked – the month the program/policy was last monitored
- Type - types of regulations/programs included:
 - Policy
 - Law
 - Executive Order
 - Bill
 - Program
 - Plan
 - Budget
 - Other
- Passed (only for laws, polices, executive orders, and bills)
 - Passed
 - Not Passed
 - Under Review
 - N/A
- Status (for programs, budgets, and plans):
 - Ongoing
 - Ended
 - N/A

This project can be summarized as a 3-step process:
