

Importance of ADA

- State and local law under the ADA states that both public and private entities must provide reasonable accommodation to mitigate the barriers attributed to disability.
- Disability is defined as "substantial limited impairment" including both mental (ie neurological) and physical
 - Hearing loss/hard of hearing/deafness can fall under either or both of those categories
