What you need to know about upcoming changes to the **DREXEL UNIVERSITY RETIREMENT PLANS**

EFFECTIVE MAY 2, 2011

Why is the plan changing?

In addition to complying with new federal regulations, Drexel University and Drexel University College of Medicine are committed to giving their employees competitive retirement benefits. In evaluating the objectives and costs of the funds in the existing lineup, we saw an opportunity to revamp the retirement plans to keep them in line with those of similar-sized institutions.

What are the main changes to the retirement program?

A number of existing choices are being discontinued, replaced by a new array of mutual fund choices.

When will these changes go into effect?

The new investment lineup will go into effect May 2, 2011.

How are the contributions changing?

Contribution rates are remaining the same. Of course, you can elect to increase your salary deferral anytime you wish within IRS limits.

What happens to balances I have in the discontinued funds?

You have until June 2, 2011 to transfer these balances into other choices offered by the plans.

What happens if I have not reallocated the balances by June 2?

The balances will be automatically transferred to an age-appropriate TIAA-CREF Lifecycle Index Fund.

What about my future contributions which are allocated to the discontinued funds? Any contributions directed to funds no longer offered by the plans will be invested in an age-appropriate TIAA-CREF Lifecycle Index fund.

Will I receive confirmation of changes to my personal investment mix? Yes, TIAA-CREF will send updated confirmations to reflect any portfolio changes.
