Starting May 2, 2011, Drexel University and Drexel University College of Medicine, in conjunction with TIAA-CREF, will be initiating a number of changes to the institution's retirement plans. These plan changes will provide wide-ranging investment choice, keep the plans compliant with new federal regulations, and bring your retirement benefits more in line with other similar organizations across the country. As we begin the transition, I want to share with you exactly what you can expect.

## NEW ADDITIONS TO THE INVESTMENT MENU

An array of new mutual funds are being added to the plans' investment lineup. These funds were specially selected for their suitability, performance and costs. While past performance is no guarantee of future results, Drexel and its investment advisors feel that this fund array gives you good potential, flexibility and value in building a retirement portfolio targeted to your unique long-term goals.

The Lifecycle Index Funds being added are a type called the Premier Share Class. This Share Class brings with it lower costs than the previous menu of Lifecycle Funds. In fact, with this new investment lineup, you are getting a selection of funds with one of the lowest ranges of overall expenses available.

## WHAT'S STAYING THE SAME

The plan's existing 10 annuity accounts are staying exactly as they are. If your balances are wholly in one or more of these accounts, there's no action that you need to take. You can, of course, reallocate your balances and future contributions to any of the plan's choices as you wish.

# **NEW OPPORTUNITIES FOR YOUR EXISTING BALANCES**

The following funds are no longer going to be offered by the plans. You should reallocate any balances you have in these funds to choices in the new fund lineup by June 2. If you do not reallocate by June 2, those balances will be transferred to an age-appropriate lifecycle fund. Also, any future contributions that are directed to the closed funds will automatically be redirected to the age-appropriate lifecycle funds.
