BIOGRAPHIES OF PLENARY SPEAKERS

Howard Zehr, PhD

Widely known as "the grandfather of restorative justice," Dr. Zehr began as a practitioner and theorist in restorative justice in the late 1970s, the foundational stage of the field. He has led hundreds of events in more than 25 countries and 35 states, including trainings and consultations on restorative justice, victim-offender conferencing, judicial reform, and other criminal justice matters. He has a BA from Morehouse College, a MA from the University of Chicago and a PhD from Rutgers University. In 1996 he joined the faculty of the Center for Justice & Peacebuilding, an international graduate program at Eastern Mennonite University. In 2013 Zehr retired from active classroom teaching but continues to be involved in the field through the Zehr Institute of Restorative Justice at the Center for Justice & Peacebuilding, Eastern Mennonite University. His books include Changing Lenses: A New Focus for Crime and Justice, The Little Book of Restorative Justice, and three photo/interview books: Doing Life: Reflections of Men and Women Serving Life Sentences, Transcending: Reflections of Crime Victims and What Will Happen to Me (children of incarcerated parents).

Jeanne Flavin, PhD

Jeanne Flavin is a Professor of Sociology at Fordham University in New York City. She has a BA from the University of Kansas and MA and PhD from American University. Her scholarship examines gender, crime, and justice. She wrote the award-winning Our Bodies, Our Crimes: Policing Women's Reproduction in America(NYU,2009), is co-editor of Race, Gender, and Punishment: From Colonialism to the War on Terror (Rutgers, 2007), and author of more than two dozen other scholarly publications. She

accepted a Fulbright research award in 2009 to study gender, family, and crime in South Africa and was the 2013 recipient of a Sociologists for Women in Society award for social action. Currently, Dr. Flavin serves on the board of directors for National Advocates for Pregnant Women, an organization that defends the rights and dignity of pregnant women, including those whose mental health, drug use, race, or poverty make them vulnerable to arrest and prosecution. Jeanne grew up on a farm in rural Kansas.

Colwin Williams

Colwin Williams, an Outreach Worker for Philadelphia CeaseFire, speaks for change. He believes the youth of Philadelphia are killing themselves needlessly and senselessly. The biggest problem in his view, is that there are few black men to give the youth of Philadelphia the structure and tools necessary for them to be successful in society. He uses his words motivate his team, encourage North Philadelphians to rally for peace following shootings, and to resolve conflicts. According to Colwin, gun violence in Philadelphia is more complicated than a proliferation of weapons on the street, or blurbs on the 10 p.m. news. Gun violence is a product of a culture of violence. According to Colwin, "the streets don't have any love at all. It's a sick relationship. You would think it would be easy for someone to say," I don't want this lifestyle, but when it's learned behavior it becomes a part of who you are." In addition to working at Temple University, Medicine's Philadelphia School of Ceasefire program, Colwin is a volunteer mentor for the Criminal Justice Center, a member of the City of Philadelphia's Re-Entry Think Tank and a motivational speaker.

Brain Injury in Juvenile Justice Youth: A Hidden Disability Monica Vaccaro, MS; MJ Schmidt, MA

Research indicates that brain injury is over-represented in the criminal justice system. Whether acquired through accident, disease or multiple injuries across time, brain injury affects individuals in profound ways. Often undiagnosed in this population, brain injury can affect academic and vocational success as well as both risk and responsivity to treatment. This session will provide basic education on brain injury, discuss literature on prevalence and effect of brain in jury on youth in the system, and will describe a grant-funded project which seeks to identify and assist those youths. Screening tools and possible resources will also be discussed.

Community MH 101: What's Out There Danny Beauchamp, BS, Stacy Tekely, MS; Hazel Dacus, MSW; Jessica Shires

This presentation will provide an overview of the variety of mental health treatment and support services available in the community mental health system. Details about the types of services, methods of treatment, and the criteria needing to be met for an individual to be referred

will be discussed. Participants will be able to summarize community-based behavioral health services, compare different levels of care, and understand the necessary criteria to refer a person for services. A panel discussion will ensue with information about the requirements of the county referral and the reentry planning process.

In working with inmates, one will be confronted with individuals who have religious fixation or a religious delusional system. To navigate and carefully minister and separate the emotional and spiritual needs and at the same time affirm the dignity of the person, while maintaining custody and control, takes a good deal of work. This session will explore venues afforded as a contract Chaplin working at SCI Waymart. This experience is garnered from 30 years in the field and development of over eight thousand preliminary religious assessment for the treatment teams.

Emotional Intelligence for Law Enforcement James D. Fouts, MSW, LSW

The greatest dilemma a Police Officer has is: Anyone you deal with may attack you, some are more likely to attack than others, you're not sure who it is or when it might happen, yet you're called to be professional and approachable to build trust and cooperation. Emotional Intelligence teaches skills that develop awareness of your emotions, manage your emotions, read others' emotions and manage the relationships needed to Police in the 21st Century.

Trauma Informed Principles of Care with LGBTQ People in the Criminal Justice System *Miranda L. Galbreath, MA; Michelle Wolf, MFT*

This presentation consists of five authors perspectives working with LGBTQ people who are involved in the criminal justice system. The presentation will include various components of working with LGBTQI people including the basic vocabulary of sexual orientation, and gender identity/expression (SOGIE), common attitudes and behaviors encountered, common traumas experienced and principles of trauma informed care and a discussion of current and emerging policies and procedural considerations.

ReLink: Expanded Reentry Services for Justice Involved Minority Youth Cody J Poerio, MPH

Since 1991, Action Wellness has maintained a presence in the Philadelphia county jails to help people with HIV access medical care, social services and support, both pre-and post-release trough the Philadelphia Linkage Program. In 2016, as part of the DHS Office of Minority Health's ReLINK initiative, Action Wellness expanded its longstanding and successful programming, to assist in smoothening the reentry of justice-involved African American, Hispanic/Latino, and other minority individuals between the ages of 18 and 26 with chronic conditions. Our workshop will be a review and discussion of our expanded ReLink Care Coach Program model, its implementation and development as well as lessons learned throughout our first year of programming.

Re-entry Challenges for Women: The Working Together for Women Experience Barbara Schindler, MD; Sharlene Irving, BA

Working Together for Women (WTW), a gender-sensitive, trauma-informed program was created in 2014 in Philadelphia, PA to provide addiction and psychiatric recovery-focused treatment combined with community-based outreach, peer support and case management for women being released from incarceration. WTW's goals are to help incarcerated women with a history of substance use disorders, many with coexisting psychiatric and medical disorders, navigate their challenging reentry and reintegration into the community, promote retention in addiction treatment, facilitate reunification with children/families, and reduce relapse and recidivism. Addressing these reentry needs was equally as challenging for the program and treatment staff. This workshop will delineate the challenges faced by both reentering women and their families and the WTW staff and solutions developed to meet these challenges.

Elephants in the Forest: A Nature-based Prisoner Re-Entry Program Tina Bloom, PhD; GA Bradshaw, PhD

A key challenge that former prisoners face is cultivating psychosocial development and skills that lead to meaningful, positive and grounded lives. A re-entry program that uses science and natural history of elephants, orcas, sharks and other animals will be presented. The goal of this program is to teach prisoners self-development, empathy, stress regulation and interpersonal skills including facial and emotional recognition.

sentences: 25 years later

Approximately 25 years ago Howard Zehr conducted structured interviews and took portrait photographs with 58 men and women offenders in the PA DOC. These interviews and photos are presented in Doing life: reflections of men and women serving life sentences. In 2017 the presenter completed follow-up interviews and photographs with 25+ of the previous participants at SCI-Graterford, Muncy, Cambridge, and Camp Hill who were still incarcerated. This workshop will present those new portraits and summarize some the themes: many the men and women work as Certified Peer Specialists, train helper dogs, and talk about other strategies to "give back to society." Results will be discussed considering Erik Erickson's 7th and 8th stages of psychosocial growth.
