## RECOGNITION WALL HONORING THE DREXEL 100 TO BE INSTALLED IN THE GREAT COURT OF MAIN BUILDING

The Drexel 100 has been celebrating the University's most distinguished graduates for 27 years. The Past Chair of the Drexel 100, David R. Geltzer '77, had a vision for a physical presence on campus for the Drexel 100 inductees' names.

"I thought the University was missing an opportunity to tell visitors, especially prospective students and parents, who some of our most notable graduates have been," Geltzer said.

The Office of Institutional Advancement conducted a study and not only found a willingness at Drexel to have such a recognition wall, but also an ideal location: a large open wall just steps away from the Admission Visit Center on the second floor of the Great Court in Main Building. The new recognition wall could be a first stop as families begin their campus tour.

Mr. Geltzer was so pleased by this opportunity that he decided to sponsor the recognition wall through his Geltzer Family Foundation. Once it is completed, the Foundation will also sponsor a dedication reception. The recognition wall is expected to be ready by Fall 2019.


The recognition wall will be large enough to list all 267 of the current Drexel 100 members plus room to add names for the next

decade. It will be created by Exit Design, a firm that has produced signage around campus with a design team led by a Drexel alumna, Amy Rees '95.

The listing for each Drexel 100 member will include his/her name, graduation year, induction year, and a one to three-word description capturing the person's distinction, e.g. Entrepreneur, Civic Leader or Technology Innovator.

Members of the Drexel 100 will receive a mailing in the coming months that will allow them to confirm how they wish to be listed. Every effort will be made to accommodate members' preferences, space permitting.

*Tireless Education Advocate*  
Children's Book Author and  
Documentary Creator

Dr. Adelman is a children's book author and an advocate for bettering the lives of children and families through education, story and film. In addition to her books, Dr. Adelman created a documentary on addiction as well as social media to help children develop their creativity and interpersonal skills. She started her career as an elementary school teacher where she was nominated for the Disney Teacher of the Year Award multiple times. Dr. Adelman is a prominent civic activist and has worked with Jewish Family and Children's Service of Greater Philadelphia to create community programming. She has also served as a trustee at organizations including The Franklin Institute, Simon's Heart, Please Touch Museum, The Philadelphia School Partnership and Wissahickon Charter School.



**Brian S. Alper, MD, CoM '96**

Founder of DynaMed and  
Vice President of Innovations,  
EBSCO Health

While a medical student, Dr. Alper created DynaMed, a clinical reference tool for physicians and other health care professionals for use at the point-of-care. Today, DynaMed Plus provides a continuously updated synthesis of evidence and guidance to more than one million physicians globally and is used 20 times per minute on the web or mobile apps. Dr. Alper has facilitated commercial development of reference tools for nurses, allied health professionals and patients, and has advanced the global community with methods for guideline development (RAPADAPTE), evidence assessment (GRADE Working Group), shared decision making (Option Grid), clinical decision support (HL7), and mobilizing computable biomedical knowledge (EBMonFHIR). At Drexel, Dr. Alper serves on the Executive Advisory Board of the College of Computing & Informatics.

Mr. Bean spent 20 years at Apple Inc. where he served in several

senior roles including Vice President of World-Wide Sales Finance, Vice President of Corporate Financial Planning & Analysis, and finally Vice President of Retail, where he led a large global team of more than 500 employees and oversaw the operations of 486 stores in 19 countries. He is now an early stage investor in technology and healthcare companies and operates Brand Napa Valley winery which produces high-end California Cabernet blends. He is author of 2018's *Bless This Mess: A Picture Story of Healthcare in America*, 2016's *We CAN Fix Healthcare*, and 1999's *The Phantom Stethoscope*. His accomplishments at the company led him to be recognized as CFO of the Year, in the medium company category, by the *Philadelphia*

*Business Journal* in 2009. Mr. Masci is also a veteran who served in Korea after graduating college, and his service was celebrated with his induction into Drexel's ROTC Hall of Fame in 2016. Mr. Masci has generously invested in Drexel in ways that reflect his personal and professional experience, creating the Masci Veterans Resource Center, Masci Tutoring in Accounting Fund, and the LeBow Commuters Learning Community Fund.

**Barbara Moore, BS, CoE '65**

An early leader among women in STEM, Ms. Moore broke barriers throughout her career, starting as an engineer with the U.S. Department of Defense. Her co-op experience and Drexel degree along with an advanced degree in ocean engineering ultimately led her to become the first woman Director of the Undersea Research Program at the National Oceanic and Atmospheric Administration. Other highlights in Ms. Moore's career included being among the first women to go on oceanographic survey cruises and to lead several missions in Hydrolab, an underwater habitat. In addition to her scientific research, Ms. Moore managed and worked on diplomatic science agreements with Russia and China that helped open doors to these once politically closed maritime nations. She ended her career in the federal service by working with the Department of State to delineate the outer boundaries of the continental margin of the United States through underwater mapping.



**Joseph Mullin, BS, CoE '56;**

*Devoted Dragon in Industry and*  
*the Classroom*

*Emeritus Teaching Professor, Civil, Architectural, and Environmental Engineering, Drexel University*

Dr. Mullin educated and inspired Drexel engineering students for more than five

decades. He was first appointed an Assistant Professor in 1961 and retired as a full Teaching Professor and Associate Head of the Department of Civil, Architectural, and Environmental Engineering in 2017. He combined his passion for teaching with an active career in industry, holding leadership positions with Pennoni Associates, SCM Corporation, General Electric and S.T. Hudson Engineering, Inc. In addition to his Drexel degrees, Dr. Mullin earned his PhD from Penn State where he was a National Science Foundation Fellow. In 1992, he was honored as the Delaware Valley Engineer of the Year.

Ms. Reardon is a Fellow of the Casualty Actuarial Society. Following the sale of Broadpeak, Mr. Syed co-founded NextDocs, a global leader in providing Microsoft SharePoint-based compliance solutions to life sciences organizations. After selling NextDocs in 2015, he then co-founded PatientWing, a cloudbased platform to accelerate medical research by connecting patients and doctors to life-saving clinical trials.

## COLLABORATIONS THAT SPARK NEW INDUSTRIES AND CHANGE LIVES

### Professor Genevieve Dion Spearheads Functional Fabric Research at Drexel



She has been called an haute couture designer and a digital knitter. But the title that Genevieve Dion prefers most is “design scientist.” Dion had a stellar career in bespoke clothing and industrial design even before she arrived at Drexel in 2007 to direct the fashion design program at Westphal College of Media Arts & Design. At Drexel, Dion’s fascination with manipulating fabric evolved from high design to high technology. She recognized that the future of textiles lay in their ability to store and transmit energy and information.

By 2012, Dion’s vision of a transdisciplinary hub for functional-fabrics research at Drexel took shape, and she founded the Shima Seiki Haute Tech Lab, which is now part of the Center for Functional Fabrics (CFF). The Center spearheads collaborations that integrate Dion’s mastery of textiles and product design with the expertise across Drexel in biotechnology, medicine, material sciences, electronics and computer science.

With millions of dollars in funding from the NSF, NIH, Keck Foundation, AFFOA and the

Commonwealth of Pennsylvania, CFF’s hallmark projects include the “BellyBand,” which monitors contractions in pregnant women and respiration in premature infants, and energy-conducting yarns made with MXene, a new material discovered at Drexel.

Under Dion’s leadership, the University is playing a key role in realizing the immense promise of functional fabrics, exploring applications in health, energy, communications and national defense. Drexel is also a key stakeholder in Advanced Functional Fabrics of America (AFFOA), a \$75 million institute established by the U.S. Department of Defense to rejuvenate American textile manufacturing and bring new products to market.

More recently, AFFOA established the Pennsylvania Fabric Discovery Center (PA FDC), also managed by Dion. The PA FDC focuses on helping companies and innovators take their advanced-textile concepts from prototype to product, while also preparing the regional workforce for high quality jobs in this growing market sector.

Recently, CFF and PA FDC relocated to their new home in Schuylkill Yards, which will allow for major expansion. As an anchor tenant in this innovation district taking shape between Amtrak’s 30th Street Station and Drexel’s campus, Dion’s visionary lab will be easily accessible to industry, academia and government.

“We are designing not just the materials of the future, but the tools of the future,” emphasizes Dion. “We’re pushing the boundaries of how people work together. What emerges has almost limitless potential to ignite new industries.”

**Lucile L. Adams-Campbell, PhD** (*BS, CoAS, 1977; MS, BIOMED, 1979*), Professor of Oncology, Associate Director for Minority Health and Health Disparities Research at the Georgetown University Lombardi Comprehensive Cancer Center, and Associate Dean of Community Health and Outreach at the Georgetown University Medical Center, was named a 2018 Washingtonian of the Year by *Washingtonian* magazine in January 2019.

**Diran Apelian, ScD** (*BS, CoE, 1968*) received the 2018 Innovator of the Year Award from Worcester Polytechnic Institute (WIP).

**Howard Benson** (*BS, CoE, 1980; HD, 2015*) was featured in an interview in December 2018 on Loudwire.com titled, "Meet Howard Benson, the Producer Making Your Favorite Bands."
