

2021-2022 Dining Plan Agreement  
First-Year Resident Student

This Dining Agreement (“Agreement”) is between the undersigned student (“Student”) and Drexel University (“University”), acting through Drexel Business Services. It sets forth the terms and conditions by which the Student will use campus dining facilities provided by the University. This Agreement will be effective and legally binding on the date the Student, and if applicable, parent or guardian, electronically selects one of three Residential Mandatory Dining Plans (the “Dining Plan”) and signs and submits this Agreement via the DrexelOne portal (the “Effective Date”).

## **TERMS AND CONDITIONS**

### **1. Term of Agreement**

The term of this Agreement is one full academic year consisting of the Fall Dining Term, Winter Dining Term, and Spring Dining Term (each a “Term” and collectively the “Academic Year”) as defined below (“Academic Year”):

The Fall Dining Term begins on September 16, 2021, or the Effective Date if later, and ends on December 11, 2021.

The Winter Dining Term begins on January 2, 2022, or the Effective Date if later, and ends on March 19, 2022.

The Spring Dining Term begins on March 27, 2022, or the Effective Date if later, and ends on June 11, 2022.

### **2. Dining Plan Requirement and Rates**

First-Year students who reside in University Housing residence halls are required to select one of three Residential Mandatory Dining Plans for the Academic Year. The plan selected is referred to herein as the “Dining Plan.”

### **3. Dining Plan Changes**

The Dining Plan may be changed only as set forth in this Section 3. Students may request to change their Dining Plan selection to a different one of the three Residential Mandatory Dining Plans by the following dates.

- The last day to change a dining plan for the Fall Term is October 1, 2021.
- The last day to change a dining plan for the Winter Term is January 14, 2022.
- The last day to change a dining plan for the Spring Term is April 8, 2022.

Student will be automatically enrolled in the selected plan for subsequent Terms unless a different plan is selected.

#### 4. Dining Dollars and Meal Swipes.

- a. Dining Dollars. Dining Dollars are funds included in the Dining Plan that can be used at all Drexel Campus Dining locations and spend like a debit card, without the possibility of overdraft, but are not redeemable for cash. Dining Dollars can be used at all University Campus Dining locations during the Academic Year. Dining Dollars may be used during term breaks at select locations. Dining Dollars can be added in increments of 50 Dining Dollars via DrexelOne. Dining Dollars will roll from Fall Term to Winter Term, from Winter Term to Spring Term, and if the Student selects a Dining Plan by the second Friday of the Summer Term, from Spring Term to Summer Term (the Summer Term dining plan begins on June 20, 2022 or the Effective Date if later, and ends on September 3, 2022).
- b. Meal Swipes. Meal Swipes are meals that are included in the Dining Plan and can be used at the Handschumacher Dining Center, the Urban Eatery, and The Café at Perelman Center for Jewish Life. Meal Swipes associated with the Dining Plan may not be used during term breaks where the University is not in session.
- c. Guest Meal Swipes. Guest Meal Swipes, if any, may be used at the Handschumacher Dining Center and the Urban Eatery and will not roll from one term to another.

5. **Rates and Payment:** For specific rate information, please refer to your Dining Plan selection. The Student agrees to pay all applicable charges for the selected Dining Plan, including, but not limited to, any cancellation fees assessed. Student will be billed through Drexel Central. Payments are due in accordance with the policies and procedures posted by Drexel Central at [drexel.edu/drexelcentral](https://drexel.edu/drexelcentral).

In the event of a material campus closure, the Dining Plan offerings and associated fees will be modified based on planned operations. Dining plan holders will be notified via email to their Drexel email account of such changes.

#### 6. DragonCard ID Access

Students are required to use their DragonCard to access their Dining Plan at dining facilities. The DragonCard is property of Drexel University and is governed by the rules and regulations set forth by the University. The DragonCard is not transferable and must not be used by anyone other than the issued cardholder. Students found in violation of University and/or Campus Dining Policy may be subject to disciplinary proceedings.

- 7. Eligibility and Dining Facility Hours.** Dining facilities will be open when the residence halls are open and limited services will be provided during break periods. Dining facility hours of operation may be viewed online at [drexel.campusdish.com](https://drexel.campusdish.com).

Students must be registered and confirmed for each Term. The Dining Plan benefits are intended solely for the undersigned Student.

- 8. Unused Meal Swipes and Dining Dollars.** Meal Swipes cannot be carried over between Terms and are non-refundable. Unused Dining Dollars are forfeited at the end of business on June 11, 2022; provided, however, that if the Student enrolls in any dining plan for the Summer Dining Term, unused Dining Dollars are forfeited at the end of business on September 3, 2022.

If the Student is under the age of 18 at the time the student completes this Agreement, the Student's parent or legal guardian must also electronically sign the Agreement through the parent proxy process.
