The EC decided at the November 2016 retreat in Geneva, NY, to rename the “Best Essay Award” as the “Abioseh Porter Best Essay Award.”

This process evolved and for quite a long time involved making recommendations on salaries, salary changes, and distribution of effort to the dean.
