To receive federal student aid, you need to provide the Office of Financial Aid your “eligibility date” from question 11 on this worksheet. You can become eligible earlier in the school year if you complete an acceptable drug rehabilitation program or pass two unannounced drug tests administered by an acceptable drug rehabilitation program. Even if you are not eligible for federal student aid, you may still be eligible for aid from your state or Drexel University.

“3” means you are not eligible for federal student aid for this school year unless you complete an acceptable drug rehabilitation program or pass two unannounced drug tests administered by an acceptable drug rehabilitation program. Even if you are not eligible for federal student aid, you may still be eligible for aid from your state or Drexel University.

Answer the questions below and follow the instructions for each answer.

1. HAVE YOU EVER RECEIVED FEDERAL STUDENT AID?

Answer “No” if you have never received federal student grants, federal work-study, or federal loans. You should also answer “No” if you have never attended a college or university.

2. HAVE YOU BEEN CONVICTED FOR THE POSSESSION OR SALE OF ILLEGAL DRUGS FOR AN OFFENSE THAT OCCURRED WHILE YOU WERE RECEIVING FEDERAL STUDENT AID (GRANTS, WORK-STUDY, AND/OR LOANS)?

Include only federal and state convictions. Do not count any convictions that have been removed from your record or that occurred before you turned age 18 unless you were tried as an adult.

- b. be administered or recognized by a federal, state, or local government agency or court or a federally or state-licensed hospital, health clinic, or medical doctor
