HEERF II (CRRSAA) & III (ARP) Student Portion Report (as of 9/30/2021)

---

1. Drexel University signed and returned to the Department the Certification and Agreement in calendar year 2021. The University intends to use no less than \$6,589,634.00 to provide Emergency Financial Aid Grants to students from CRRSAA and no less than \$18,223,273.00 from ARP.
  
2. The University received \$6,589,634 in calendar year 2021 from the Department as part of CRRSAA student relief and \$18,223,273 as part of ARP student relief.
  
3. The total amount of Emergency Financial Aid Grants distributed to students as part of CRRSAA as of September 30, 2021 is \$4,112,300. The total amount distributed to students as part of ARP as of September 30, 2021 is \$11,029,425.
  
4. The total number of students eligible at Drexel University to receive Emergency Financial Aid Grants to Students under CRRSAA is 11,213. The total number of eligible students under ARP is 19,582. However, this includes both non-filers and international students. The number of domestic students that are eligible and for which Drexel University can calculate financial need is 13,330.
  
5. As of September 30, 2021, 4295 students have received an Emergency Financial Aid Grant to students as part of CRRSAA. Additionally, 4915 students have received an Emergency Financial aid grant as part of ARP as of September 30, 2021.

6. The University will award CRRSAA funds to eligible students who submit an application to confirm and attest to having been impacted by COVID-19. Grants will be distributed to eligible students based on demonstrated need in the below amounts.

**Pell eligible students who demonstrate need:**

- \$30,000 and above will be eligible for \$1,500
- \$20,000 to \$29,999 will be eligible for \$1,300
- \$10,000 to \$19,999 will be eligible for \$1,000
- \$5,000 to \$9,999 will be eligible for \$500

**Undergraduate students who are not Pell eligible and who demonstrate need:**

- \$20,000 and above will be eligible for \$1,000
- \$15,000 to \$19,999 will be eligible for \$500

**Graduate students who are not Pell eligible and who demonstrate need:**

- \$20,000 and above will be eligible for \$750

The University will award ARP funds to eligible students who submit an application to confirm and attest to having been impacted by COVID-19. Grants will be distributed based on demonstrated need in the below amounts.

**Pell eligible students who demonstrate need:**

- \$30,000 and above will be eligible for \$6,000
- \$20,000 to \$29,999 will be eligible for \$5,000
- \$15,000 to \$19,999 will be eligible for \$4,000
- \$10,000 to \$14,999 will be eligible for \$2,000
- \$5,000 to \$9,999 will be eligible for \$500

**Undergraduate students who are not Pell eligible and who demonstrate need:**

- \$30,000 and above will be eligible for \$3,345
- \$20,000 to \$29,999 will be eligible for \$2,345
- \$15,000 to \$19,999 will be eligible for \$1,000
- \$10,000 to \$14,999 will be eligible for \$750
- \$5,000 to \$9,999 will be eligible for \$500

**Graduate students who are not Pell eligible and who demonstrate need:**

- \$30,000 and above will be eligible for \$750
- \$14,999 to \$29,999 will be eligible for \$500
