- If your noncustodial parent is married, you must supply information regarding their spouse.
- Please **DO NOT** submit any additional documentation (such as tax returns) with this worksheet.
- International applicants — all financial figures must be converted into U.S. currency when completing this form.

Submission Deadlines

Submit all documentation together by the following applicable deadlines:

- Early Action — November 17
- Early Decision — November 17
- Regular Decision — February 17
