

**SUMMARY ANNUAL REPORT
FOR THE
DREXEL UNIVERSITY HEALTH AND WELFARE PLAN**

This is a summary of the annual report of the Drexel University Health and Welfare Plan, Plan Number 519, Employer Identification Number 23-1352630, for the plan year period beginning January 1, 2022, and ending December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

UNINSURED COMPONENTS

The plan sponsor, Drexel University, has committed itself to pay certain medical (including telemedicine), prescription drug, short-term disability, severance, life insurance, and the healthcare flexible spending account claims under the terms of the plan.

INSURED COMPONENTS - INSURANCE INFORMATION

The plan had contracts with insurance carriers to pay certain claims incurred under the terms of the plan. The type of benefit provided, name of the insurer, and premiums paid for each component are set forth in the table below. The total amount of premiums paid for contract years that ended during the 2022 plan year were \$5,232,753.

Paperwork Reduction Act Statement

According to the Paperwork Reduction Act of 1995 (Pub.
