## LITIGATION

### *Allegheny Reproductive Health Center v. Pa. Dep't of Human Services*

Represent all free-standing abortion clinics in Pennsylvania in state constitutional challenge to state law that bans Medicaid from covering abortion care. Argued procedural aspects of case before Pennsylvania Supreme Court on October 26, 2022, and still awaiting decision.

### *McBrayer v. Governors Ridge Property Owners Association*

Represented national medical organizations and Georgia abortion clinics in 2021 amicus brief to Georgia Court of Appeals in case in which abortion doctor was sued for private nuisance by his property association because of the protesters who were outside his clinic. Brief addressed anti-abortion harassment and violence as well as civil attacks on abortion providers.

### *June Medical Services v. Russo*

Represented Feminist Majority Foundation, NOW, Southern Poverty Law Center, and Women's Law Project in amicus brief before the U.S. Supreme Court in this 2020 case about Louisiana abortion regulations. Brief addressed the history of anti-abortion violence and its current effect on abortion providers, relying heavily on my book about the topic.

### *Crocco v. Pa. Dep't of Health*

### *Jane Does 1-10 v. David Daleiden*

Represent Southern Poverty Law Center and Feminist Majority Foundation in 2017 and 2018 amicus briefs before Ninth Circuit Court of Appeals in case about release of abortion providers' personal information in public records requests. Brief addressed the history of anti-abortion violence and its current effect on abortion providers, relying heavily on my book about the topic.

*National Abortion Federation v. Center for Medical Progress*

Represent Southern Poverty Law Center and Feminist Majority Foundation in 2016 amicus brief before Ninth Circuit Court of Appeals in case about the release of videos filmed at abortion provider annual meeting. Brief addressed the history of anti-abortion violence and its current effect on abortion providers, relying heavily on *Living in the Crosshairs*.

*Whole Woman's Health v. Hellerstedt*

Represented ten Pennsylvania abortion clinics for an amicus brief before the U.S. Supreme Court in this 2016 case about Texas abortion regulations. Amicus brief focused on the lessons from Kermit Gosnell, the criminal Philadelphia doctor, and his connection to anti-abortion laws. Brief was cited by Justice Ruth Bader Ginsburg in her concurring opinion.

*Rainbow Alliance v. University of Pittsburgh*

Represented Rainbow Alliance, a University of Pittsburgh student group for lesbian, gay, transgender, and bisexual students, in city human relations commission complaint against University of Pittsburgh for failure to accommodate transgender students. Commission found in students' favor in 2013, and then University and student group settled.

*Commonwealth v. Hanes; Ballen v. Corbett*

Represented over 30 same-sex couples in state court seeking to invalidate Pennsylvania's ban on same-sex marriage. Represented couples in original challenge to state ban as well as litigation around Montgomery County Clerk's granting of licenses over summer of 2013. Settled case in September 2014 to allow marriages to be recognized.

*B.H. v. Easton Area School District*

Represented fifteen women's organizations as amici curiae before Third Circuit in federal case involving the First Amendment rights of students to wear breast cancer awareness bracelets to school. Amicus brief focused on sex equality aspects of the case. En banc panel of the Third Circuit ruled in students' favor in August 2013.

*Kuhns v. City of Allentown*

Represented Allentown Women's Center and Jennifer Boulanger as defendants in this federal civil rights litigation concerning protest at an abortion clinic. Case was filed in June 2008, and Eastern District of Pennsylvania granted summary judgment in favor of defendants in March 2011. Third Circuit vacated the decision as moot in 2012.
