If so, please note particular events from legislative history that seem relevant to the interpretation. (We will come back to this legislative history in later classes as well, so it might be useful to flag or keep notes on the key turns in your mind.)  Do you think that the No Vehicles in the Park statute would benefit from being administered by an administrative agency or commission? Can you think of statutes that might?
