#### **Spotlight on Faculty Development**

#### Progress Monitoring and Supervision

- A variety of assessment methods exist to help us obtain data about patient progress in therapy. Many clinicians do a "scale of one to ten" approximation about patient symptoms in the past week. Others use specialized assessment tools to measure progress, such as validated rating scales like the PHQ-9. Data about progress monitoring underscore how important it is to use such scales, since multiple studies demonstrate that we are not capable of "just knowing" how a patient is progressing by either their self-report or our clinical acumen. Measurement based care truly improves outcomes. Progress monitoring, when coupled with feedback to the patient about progress, increases the effectiveness of therapy and decreases negative or adverse responses to therapy (1).
- Teaching residents to gather feedback in supervision is therefore an essential. First, assessment of patient progress must regularly occur with a validated rating instrument. Second, measuring the strength of the therapeutic alliance is quite important to therapeutic progress. An alliance measure is certainly important at minimum in those patients with whom the therapeutic alliance poses particular challenges. Measures that determine whether the therapy is being deployed as intended should be used in supervision when available. CBT, for example, has rating instruments that indicate if the therapist is performing CBT to a level of fidelity.
- What is even more critical is having a conversation with the supervisee regarding the indicators of patient progress, using targeted questions to help the supervisee generate hypotheses about them and teaching how to discuss them with the patient. Questions like "How do we account for the jump in progress or the lack of progress? What does this score mean about your relationship with the patient? What should you do next?" will further critical thinking and therapist growth. Such dialogue may lead to discussions of therapeutic impasses, alliance ruptures, incorrect case conceptualization or unrecognized comorbidities. The patient may develop a better relationship with the therapist and a renewed resolve regarding the work of therapy.
- The weekly use of symptom measures seamlessly integrated into clinical care and discussed with the patient improves outcomes. Countless patients receiving therapy in research trials employ such scales routinely (and generally get superior outcomes). Supervision should incorporate these principles.
